HISTORY OF THEN RTA!!!! The RTA was formed in January of 2001 to obtain and protect benefits for those Retired State Police Officers prior to the MERGE. LISTED BELOW IS WHAT WE HAVE FOR BENEFITS FOR OUR MEMBERS.

BENEFITS: For those Retirees who may consider joining the RTA: RTA offers both Dental and Optical Insurance. The RTA Plan has just two categories: Single and Family plans. For those members who do not have children eligible for the Family plan, the member and spouse are - can be covered as single members. This is a savings over the State offered Dental plan. The state plan requires that the retiree must take the family plan even without children. The RTA Plan thru Delta Dental has not had an INCREASE IN 15 years!! The Ameritus Eye Care Plan offers coverage for our retirees. If you want any further information about these plans contact RTA. RTA qualifies its members for the HAR-218 program which allows retired police officers to carry firearms anywhere in the country. RTA holds 2 sessions each year. The charge is \$40.00.
