The Delta Dental plan offered by the RTA the best for retirees. The RTA Plan has just two categories: Single and Family Plans. For those members who do not have children, the member and his/her spouse can be covered with single plans at a savings over the state plan. In the state plan they would have to take the family plan with or without children. The cost of the RTA plan has been stable for 14 years. The Ameritas Eye Care plan offers coverage for our retirees. If you want any further information about the Delta Dental and/or Ameritas, or any other benefits offered to RTA members contact RTA. In addition, RTA qualifies its members for the HR-218 program which allows retired police officers to carry anywhere in the country. We do this twice a year and will offer more sessions if the need arises. We charge \$40.00 per person for each session and is **only offered to RTA members.**
